The Arizona Alpha chapter house has provided a strong foundation for our sisterhood spanning decades, and we know it will play a central role in our long term success. We are in the midst of a \$3M renovation/expansion with an anticipated completion by fall term 2020. **Why is now the right time to invest in Arizona Alpha?**

With nearly 350 members, our women simply don't fit in the house any more. They are forced to rent auditorium spaces for meetings ... sterile spaces that diminish the sacred use of our ritual. They can't even hold a Formal Dinner, a Cookie Shine or educational and sisterhood activities to include all members.

Built in 1929, our beautiful house is in desperate need of upgrades. Many sororities have already completed major renovations or built newer facilities ... Pi Phi is beginning to pale in comparison. We must upgrade our house if we are to remain competitive and provide a positive experience for our members!

Our expanded Arizona Alpha Chapter House will include:

- Former dining room enlarged and equipped as a multipurpose area, lovingly referred to as "Ring Ching Hall"
- A new self-serve kitchenette with outdoor café seating
- Increased & enhanced study space throughout the house
- Expanded restroom facilities on the lower level
- ADA compliance, ensuring accessibility and inclusion for members, alumnae, employees and guests with special needs

In order ensure success, we have set these fundraising goals:

- \$1.5M pledged by Recruitment 2020 ~ Required to proceed!
- Ideal: \$2.5M over 5 years to eliminate using the house as collateral
